### Relevant Laws

**Sections 311, 312 and 324 or Title III of the Superfund Amendments and Reauthorization Act of 1986** (SARA) mandate that the public shall be provided access to facility specific chemical inventories, material safety data sheets (MSDS) and local emergency response plans.

**Ohio Revised Code Section 3750.02 (B) 2 c** – The SERC Shall: Adopt rules in accordance with Chapter 119 of the Revised Code to implement and administer this chapter that may be more stringent than the "Emergency Planning and Community Right-To-Know Act of 1986," 100 Stat. 1729, 11001, and regulations adopted under it. Rules adopted under division (B)(2) of this section shall not be inconsistent with that act or the regulations adopted under it.
